RCTS (Regulatory Compliance Tracking Solution) provides early warning notifications based on over 30 categories of pre-defined compliance violation rule sets.



## WHAT IS RCTS?

RCTS enables organizations to comply with various forms of regulations and to protect the communication networks from misuse and abuse. RCTS is a comprehensive Information Technology (IT) solution that helps manage potential government act violations and abuse across your entire network with efficiency, simplicity, and reliability. RCTS enables the organization to capture, store, analyze, and report on any traffic that could be a possible regulatory violation.

## HOW DOES IT WORK?

RCTS passively captures traffic, and then reports on any information or potential violations to either the GLBA, HIPAA, SOX, CSB 1386, or the USA Patriot Act. A full account of the violation is retained for further investigation or reporting. RCTS may be customized to store desired information for short term retrieval or archive for reporting at a later date.

Customers will want RCTS to detect unauthorized release of information unique to their specific industry — patient information, corporate proprietary information, financial data, insider trading, intellectual property, or other sensitive information. By protecting this information, RCTS helps ensure compliance with the Health Insurance Portability and Accountability Act (HIPAA), the Sarbanes-Oxley Act (SOX), the California Senate Bill 1386 (SB-1386), the Gramm-Leach-Bliley Data Protection Act, and the USA Patriot Act. Non-Compliance with these acts in today's environment is the kiss of death for an organization. There is no other tool on the market today which can ensure Company Executives are compliant across multiple governmental Acts.

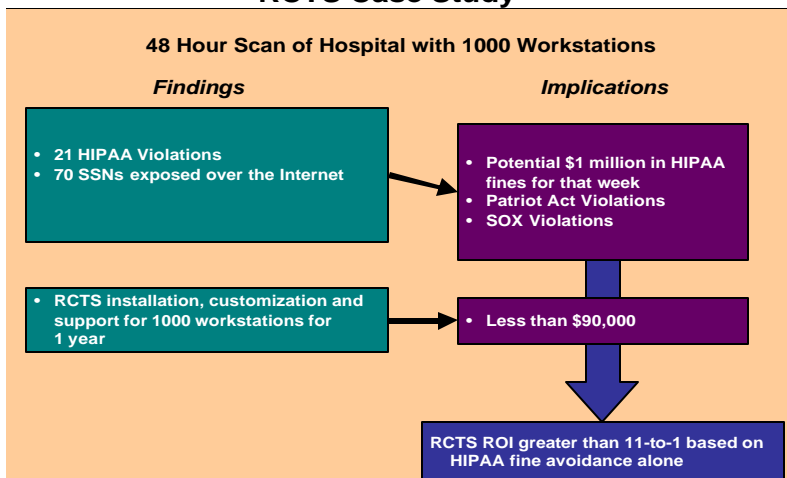
